STALLION SERVICE CONTRACT

This STALLION BREEDING CONTRACT FOR THE BREEDING SEASON OF 20\_\_, is made and entered into on this \_\_\_\_ day of \_\_\_\_\_, 20\_\_ , is by and between STEVEN M SANDVIG, hereinafter designated breeder and \_\_\_\_\_ hereinafter designated MARE OWNER, agrees to breed mare named \_\_\_\_\_, Reg. No. \_\_\_\_\_ to the stallion AN EDUCATED GUESS, for the fee of \$ \_\_\_\_\_ for a live foal, subject to the following conditions:

1. This Contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal which stands and nurses without assistance. If a foal is born dead, there are return privileges for the 20\_\_ season only if Breeder is notified within 7 days and receives a veterinarian's statement confirming death. If after being pronounced "safe in foal", the mare should miscarry, abort or prove barren, MARE OWNER has the privilege to breed her during the current breeding season, February 1 through July 1, or the following year, 20\_\_.
2. A Breeder's Certificate will be issued for the foal, conceived by this mating, when the stallion fee and all other expenses have been paid in full; and when the mare has produced a live foal by this mating.
3. It is further agreed that should the stallion die, be sold by the owner, or become unfit for service prior to settling the mare, that the breeding fee shall be refunded, if it has been paid in full, thereby canceling the entire contract; or if the mare dies or becomes unfit to breed before being pronounced safe in foal, the BREEDER has the option to either (a) accept another mare as a replacement, or (b) refund the breeding fee, if it has already been paid in full, thereby canceling this entire contract.
4. This Contract is non assignable and non-transferable. The MARE OWNER is responsible for all personal property taxes on the mare.
5. The Contract is entered into the State of Washington, and will be interpreted and enforced under the laws of that state. If any clause in this Contract is against State Law, then that clause shall be null and void.
6. It is understood that the money paid is for BREEDING FEE ONLY. All stallion collection costs are through CHAMBERS PRAIRIE VETERINARY HOSPITAL, 3100 YELM HWY, S.E., OLYMPIA, WA 98501, PHONE (360)491-3800. MARE OWNER must call the veterinary hospital prior to stallion collection and establish an account. MARE OWNER will be billed directly by Chambers Prairie Veterinary Hospital and be responsible for the payment of all semen collection costs. In addition, person receiving shipped semen will be responsible for the container rental fee and shipping costs.
7. Additional conditions should be individually initialed by each party. If none check here \_\_\_\_\_.
8. A copy of the mare's registration certificate shall be provided to STALLION OWNER.
9. This Contract represents the entire agreement between the parties. No other agreements or promises, verbal or implied are included unless specifically stated in this Contract.

When MARE OWNER and BREEDER sign this Contract, it will then be binding on both parties, subject to the above terms and conditions.
